Continuing to invest in our electricity network to meet your needs

### From 1 April 2021, Powerco's electricity distribution prices will remain the same as last year on average.

We update our prices annually to reflect changes in how our network is used, such as the number of customers and the cost of meeting their electricity needs.

This year's change is a combination of:

Distribution	-1.0%
Transmission	2.5%
Overall	0.0%

The impact on your electricity bill will depend on your circumstances and how your retailer chooses to repackage these changes for you.


We continue to invest in your community to keep the lights on and the electricity flowing. We do this safely, reliably, cost-effectively, and sustainably – you can read more about our sustainability goals on our website, including our netzero at 2030 emissions target. Powerco owns and manages the poles, wires, transformers and substations that bring power to your door. We invoice retailers that use our electricity networks, and these charges make up around a quarter of your overall electricity bill. We also pass on Transpower's charges for using the national transmission network (often called the National Grid).

Transmission charges can vary between regions but are around 11% of your overall electricity bill. Retailers then invoice customers for all electricity costs.
